How to Apply

If this resonates, we'd love to hear from you! Your application package will consist of your resume and answers to the following three questions (150 words max for each answer):

1. Our mission is, "To assist immigrant and refugee women and their families to become full and participating members of Canadian Society." In what ways does this resonate with you?
2. At our board, we are best served by people who possess the following skills: they are good listeners and question-askers; they are comfortable working individually and in small teams, and welcome change. Can you list one or two examples where you have demonstrated any of these skills?
3. What does equity and inclusion mean to you?
